Lahir pada tahun 1958. Lulusan S1 ITB Elektroteknik, MM-IPMI, dan MBA dari Monash University (External) Melbourne (1996). Memperoleh dua gelar PhD (doktor) yaitu di bidang Manajemen Keuangan (2001) dan Ekonomi Moneter (2004) dari Universitas Indonesia. Kedua-duanya memperoleh penghargaan dari Musium Rekor Indonesia (MURI) sebagai peraih gelar doktor tercepat di Indonesia. Mengawali karir di bidang pembangunan konstruksi dan gedung sejak tahun 1983 dan terakhir sebagai project director Gedung Graha Niaga II (sekarang bernama Gedung Medco).

Beliau beralih karir pada bidang pengelolaan bisnis dan keuangan sejak 2001, yaitu sebagai Direktur PT Bhakti Investama Tbk (2001-2003), PT Agis Tbk (2002-2003), Komisaris PT Datakom Asia (2002-2003), Direktur PT Surya Citra Media Tbk (2004-2005), Kepala Satuan Usaha Komersil ITB Bandung (2005), Direktur PT Mitrasari Kartikatama (2005-2007), Direktur Corporate Strategy & Project Office Management PT Smart Telecom (2007), direktur independen PT Garudafood Putra Putri Jaya (2008-2009), komisaris utama PT Greenwood Sejahtera Tbk (2011-2013), dan corporate advisor PT Greenwood Sejahtera Tbk (2013- sekarang).
